Cookies: what they are and what they are used for

"Cookies" are small text files that some websites send to your computer or mobile device when you access a site or use its services. The purpose is to acquire and transport information. Cookies are sent by the web server (on which the visited site is running) to the browser you are using (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) and then stored on your computer.

In general, cookies can be used for various reasons, for example to measure site usage by visitors, improve page navigation, to allow you to set personal preferences on sites you are visiting, or even to protect security user.

The types of cookies we use

While browsing the internet, some information is automatically recorded such as: the name of your Internet access provider, the site of origin, the pages visited, the duration of the visit, etc. This information will be recorded in a completely anonymous form.

The cookies used by our sites can be classified according to the purpose pursued as described below:

Static cookies

They are used in aggregate form for statistical purposes of the Site and to monitor, always in aggregate and never individual form, which pages of the Site and which Services are most appreciated by Users.

These cookies are used only to help us improve how our site works and understand the interests of our users.

Session cookies

They are used only to allow access to some Website Services and are stored for the duration of the browsing session and are therefore deleted.

Mozilla Firefox

From the drop-down menu in the upper left corner select 'Options'. In the pop up window select 'Privacy'. Here you can adjust your cookie settings.

Safari

From the pull-down menu in the upper right corner select 'Preferences'. Select 'Security' and here you can adjust your cookie settings.
