- obtain information on the existence of your right to rectify or cancel your personal data or on your right to limit the processing of the same;
- obtain information on the existence of your right to lodge a complaint with the Guarantor for the protection of personal data;
- obtain information on the possible use of an automated decision-making process in the processing
 of your personal data, including the logic used and the consequences for your consideration
 provided for such treatment;
- rectify your personal data, pursuant to art. 16 of the reg. (E.U.), in case of unexpected dispute of the exactness of the same;
- integrate your personal data, pursuant to art. 16 of the reg. (E.U.), in case of unexpected dispute of the completeness of the same;

- cancel your personal data, pursuant to art. 17 of the reg. (E.U.), unless it is necessary to fulfill a legal obligation to the contrary or to ascertain, exercise or defend a right in court, in the event of:
- supervening absence of need to process such personal data for the stated purposes;
